ASSEMBLY INSTRUCTIONS

1. PULL ONE SIDE OF FRAME OUT UNTIL IT LOCKS (FIG. A). REPEAT FOR OTHER SIDE (FIG. B).



2. SPREAD OPEN BASE UNTIL IT LOCKS INTO PLACE.



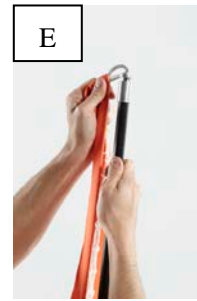
3. THREAD STAKE BUNGEE CORD THROUGH GROMMETS AND LOOP OVER ANGLED TUBES AS SHOWN.



- 4. JOIN POLES (FIG. C) AND THREAD POLE THROUGH SLEEVE WITH COUPLING END FACING UP. PLACE INTO ANGLED TUBE ENDS (FIG. D). REPEAT ON OPPOSITE SIDE.



- 5. HOLD POLE WHILE PULLING NET UPWARD. PLACE WHITE ROPE OVER POLE TOPS (FIG. E).



- 6. STAKE THROUGH RINGS ON BUNGEE CORDS (OUTSIDE THE GOAL MOUTH) TO SECURE GOAL TO THE GROUND.



- 7. TO TAKE DOWN, REMOVE POLES AND PRESS HINGE BUTTONS TO COLLAPSE LEGS AND FRAME.
