ASSEMBLY INSTRUCTIONS

1. PLACE DOUBLE HINGE ON GROUND WITH NET SPREAD AWAY FROM YOU. PULL ONE SIDE OF FRAME UP UNTIL IT LOCKS (FIG. A). REPEAT FOR OTHER SIDE. OPEN THE FRAME UNTIL IT LOCKS INTO PLACE (FIG. B).







2. OPEN OUTER HINGES OF FRAME UNTIL THEY LOCK INTO PLACE



3. THREAD STAKE BUNGEE CORD OVER FRONT ANGLED TUBES AS SHOWN.



4. JOIN POLES (FIG. C). INSERT UPPER POLE "B" (2) INTO LOWER POLE "A" (2), THEN INTO THE REAR ANGLED FRAME.





5. THREAD TWO REMAINING POLES THROUGH SLEEVES AND INSERT INTO FRONT ANGLED TUBES.



6. PLACE WHITE ROPE OVER POLE TOP (FIG. D). START WITH THE FRONT POLES (FIG. E) FOLLOWED BY THE REAR POLES (FIG. F).








7. PULL BLACK WEBBING LOOP OVER LIP OF FRAME UNTIL THE LOOP RESTS IN FRONT OF RUBBER FOOT (FIG. G). REPEAT FOR BOTH SIDES.





8. STAKE GOAL TO GROUND (OUTSIDE OF GOAL MOUTH) USING BUNGEE STAKE LOOPS.
